## Area 9 Assembly May 2024

Welcome Florida North,

I am grateful for the opportunity to provide you with all the necessary information to allow us to participate in Al-Anon and Alateen recovery.

*From Al-Anon/Alateen Service Manual 2022-2025:*

*The AAPP is a member who serves as the Area's designated Alateen contact with WSO AFG Records regarding Alateen forms and processes all Alateen group and AMIAS information for the Area. The AAPP collaborates with the Area Alateen Coordinator concerning the distribution and submission of Alateen forms and WSO reports. (p. 75)*

Recertification with the WSO: The recertification process started last fall and to date we have 84 active AMAIS'. We have 19 new AMAIS's since the Fall of 2023 with 11 of them being since the start of this Panel. We are making progress and have about 64% of the AMAIS's recertified. We appreciate everyone that has already attended a FRESH Event and had their background checks completed. We have one more FRESH Event planned and the Alateen Coordinator will provide information on that.

We have also made progress with verifying the current Alateen Groups, we have seen some growth which is very exciting for us.

Are you or someone in your group interested in becoming an AMAIS? Please contact your District Representative or our Alateen Coordinator. It is possible for Districts to schedule online FRESH Events if you or someone else misses the last one before the recertification period ends. Alateen Groups: We currently have 20 Active Alateen Groups

Certified AMAIS: We currently have 55 Certified AMAIS

1. Current **Area Safety and Behavioral Requirements**
2. Panel 64 **Area 9 2024 AMIAS Certification Form** that all AMIAS need to complete.
3. Panel 64 **Area 9 2024 Alateen Group Sponsor Form** to fill out if you are the Group Sponsor for an Alateen Meeting.
4. Panel 62 **VECHS Waiver Form**, which needs to be filled out, and the original mailed to the AAPP (the address on the form is updated).

If you are an AMAIS in our Area, please keep in touch with me regarding any changes so we can ensure records are up to date. If you move or change your email, we need to have it updated with the WSO records to avoid returned mailed or bounced emails. If mail is returned or an email is bounced back, it will result in inactivation from WSO.

For my Group Sponsors, if you have not already, please return the 2024 Annual Alateen Group Recertification Form to me, you can mail it or scan and email it to me. Additionally, I need a current Area 9 Alateen Group Sponsor form for every group you sponsor.
